INFORMATION & REPORTS

A. Rocket Registration

Mr. Owen presented details of the Rocket Registration event that will be held on Tuesday, August 10 @ KHS. This event is for both returning students and for new students to register for the 2021-22 school year. Representation from various groups will be available to share resources with parents and students such as KDL, athletics, transportation, free meals from food service, mental health clinicians, the DOCK, etc. Students will also have the opportunity to receive their schedules, IDS, and other school related information. Mr. Owen shared appreciation to all of the staff who have worked to put this event together and for all those who will work the event to welcome families to the new school year.

B. Employee Orientation

Mr. Alcorn shared highlights of the new staff orientation that will take place on Monday, August 16th. A variety of information will be shared with new staff to welcome them to Kville.

C. COVID Guidelines

Mr. Alcorn presented a summary of recent CDC and health department guidelines for COVID and the position of KISD Superintendent's as the start of the new school year is less than two (2) weeks away. Risk levels have risen and the CDC's recommendations on vaccines, masks, and other mitigation procedures are rapidly changing. He share a copy of a recent letter that went out to Kville parents on guidelines that the district will implement for the return to school but indicated that these procedures will change accordingly as CDC and health department guidelines are updated.
