## <u>PROPOSAL</u>

# A. <u>Kelloggsville Public Schools Diplomas</u>

Mr. Patin, Mrs. Sherman, and Mrs. Taylor shared a proposal to change the school name on all diplomas. Currently, with three (3) high schools in the district; KHS, KVS, and 54<sup>th</sup> Street Academy, the diplomas read "Kelloggsville High School". This proposal would update them to read "Kelloggsville Public Schools". This change will provide consistency for all of our graduates and show that they are products of our district, rather than a specific secondary building. It would also then allow the transcripts to correctly identify which program/building they graduate from and reduce confusion for colleges and universities. It was noted that many other districts in the area, that offer multiple graduation options, have updated their diplomas to represent their district name. This proposal will be placed on the 11/28/22 agenda as a consent item.

## B. Entrepreneurship Field Trip

Tyler Eberts, a student in Mr. Zuiderveen's Entrepreneurship Class, presented details on a proposal for the 3rd hour class of seniors to travel to Chicago, IL in March 2023. He shared that the trip would allow students the opportunity to experience hands-on learning and provide a unique educational experience that is on a level of business difficult to learn in the classroom. The trip would consist of a two (2)-night stay, with students fundraising for the cost of lodging, food, and entertainment with transportation provided by district vans. While there, the students would visit the Chicago Stock Exchange, visit local businesses and connect with the Junior Achievement Chicago President, along with other hands-on learning opportunities and visits to local attractions. Following the trip, the students would like to make a presentation to the Board to share their experiences and the information they learned. This proposal will be placed on the 11/28/22 agenda as a consent item.

## Information & Reports

# A. Junior Achievement – West Michigan Business Hall of Fame

KHS students, Amyah Hodges and Demarreon Rodriguez, shared highlights of the JA West Michigan Business Hall of Fame that they served as student ambassadors to assist guests throughout the event and serve as emcees for the program. and have earned the respect of the local community and serve as a role model for students. Amyah and Demarreon shared that this event provides them an opportunity to network with business professionals to help them develop skills and inspire them to be future business leaders themselves. Mr. Zuiderveen noted that Kelloggsville students began participating in this event three (3) years ago and JA specifically requested the return of KHS students because they do such an outstanding job and represent the District by having a great reputation within the business community.

## B. State of the Student

Earlier this year, Kent ISD created a Student Leadership Community comprised of two (2) students from each school in Kent County. The group was designed to raise student voices and provide them the opportunity to share their thoughts about their K-12 experience, as well as provide input for the future of education in the county. KHS students, Moneek Pharms and Alex Aguilar-Lopez, represented KPS and shared with the Board their experience on serving on the panel with other students and superintendents at a State of the Student luncheon, titled Listen. Learn. Lead. They shared what a great opportunity it was to have their voices shared with other students and school leaders on the challenges they face, specifically returning to school following COVID. The Board thanked them for representing Kelloggsville and participating in this valuable opportunity.

## C. <u>Professional Development Day 11/11/22</u>

Mr. Owen shared the details of the professional development activities that staff took part in on November 11<sup>th</sup>. Part of the day consisted of all staff attending a DEI Staff/Student Panel that included topics on cultural insights, micro aggressions, and the impact they have within the classroom. Additional PD included department and grade level meetings, Restorative Circles, various curriculum work and trainings, and special education/itinerant specific trainings. Feedback on the DEI Staff/Student Panels was extremely positive, especially hearing from students, having a significant impact on how teachers feel about their classrooms. The next Professional Develop Day is scheduled for Monday, January 16<sup>th</sup>.
