## A. Athletic Program Update

Mr. Alcorn shared an update on the changes that have occurred with the newest rulings on spectator limitations for MHSAA events. As the fall athletic season winds down, he shared seating numbers for both indoor and outdoor events, ticket sale procedures, and the latest in social distancing mandates set forth by the MDHHS, which includes the requirement of masks and contact tracing information for all spectators.

#### B. PBIS Update

Mr. Owen reviewed the PBIS/PSC programs that are continuing for the 2020-21 school year. He shared a brief summary of how the program focuses on a proactive approach to student behaviors using a prevention vs. punishment method and a tied system of support and interventions. He highlighted key components to the program including the implementation of a rewards system which was very successful last year and is currently being used in a more hybrid method this school year. He also shared how data is analyzed to improve the plans that are currently in place and noted that this program has shown success and is hopeful to share some of the results with the Board in the spring.

## **OTHER MATTERS**

- Mr. Owen shared his experience in working with Mr. Pomorski when he was the Principal of West Kelloggsville. Tim and Renee Pomorski were prominent members of the PTG and very active in the school community, which continued far after his service at the elementary level. Tim's dedication will truly be missed.
